

**Release of Liability, Waiver, Assumption of Risk, Hold Harmless,  
Photo Release and Indemnification Agreement**

1. **Representation:** I represent that I am the parent or legal guardian of the Participant(s) named below or I have obtained permission from the parent/legal guardian of the Participant(s) named below to execute this agreement on their behalf.

5. **Photo Release:** I hereby authorize and consent to the use of my and the Participant(s) visual image by *Jump In With Us* and *Jump In With Us, Inc.* for appropriate purposes, including but not limited to: still photography, videotape, electronic and print publications and websites. I give this consent with no claim for payment.
